Summary

The report reviews published research, consultancy reports; related conference outputs, and external talks from students and staff of the Royal Agricultural University in 2015.

Contributions are again dominated by staff from the School of Agriculture, Food and Environment with research projects involving PhD students; extremely pleasing to note a peer reviewed journal paper by undergraduate student Daisy Irons (third year student on the BSc (Hons) Agriculture degree programme), for research carried out during her sandwich placement at Rothamsted.

It has also been helpful having postdoctoral researchers working at RAU and contributing to research papers and publications, namely Dr Rosmiza Mohd Zainol (- seconded from Universiti Kebangsaan Malaysia (UKM), Malaysia);
Dr Negin Minaei (- from Islamic Azad University (IAU), Iran), and
Dr Karen Rial-Lovera (continuing at RAU currently following her PhD studies).

There is growing research and consultancy in the School of Real Estate and Land Management. The School of Equine Science and Management has continued the excellent start made last year by recruiting 2 new MSc by Research postgraduates and 2 new PhD students.

Compared to last year, a similar number of papers in refereed journals were published in 2015 (at 30 / 2014:27) – 14 from SAFE colleagues; 11 from RELM; 3 from SEMS, and 2 from SBE. The book contributions were published by Rita Walsh in SBE; Professor Meriel Moore-Colyer in SEMS, and Professor Sarah Sayce and Will Manley in RELM.
